Populations Are Decreasing, SAVE THE BEES But You Can Help!

Spring is officially here. The grass is green again, trees have regrown their leaves, and flowers are emerging from the earth. Busy bees are ready to pollinate the new blossoms, but sadly, the rusty patched bumble bee may not be around to pollinate much longer.

The rusty patched bumble bee is one of 47 species of bee native to North America. These bees are "buzz pollinators," which means they cling tightly to a flower and vibrate their flight muscles to collect pollen. In this way, the bees pollinate blueberries, cranberries, clover, and tomatoes.

Once ranging from North Dakota to Maine and Quebec and as far south as Georgia, the bee's population has declined by 87 percent since the 1990s. Experts now consider the rusty patched bumble bee to be on the brink of extinction. President Obama made the rusty patched

bumble bee a priority by placing it on the endangered species list in January.

The reasons for the bee's decline are not fully understood, but it is hypothesized that habitat loss, diseases, parasites, pesticides, pollution, and climate change may have something to do with it.

Not all hope is lost. The U.S. Fish and Wildlife Service has some suggestions for stopping the bee's decline. Individuals can plant native flowers, limit their use of pesticides, and avoid cutting grass and garden plants after summer to provide a habitat for bees during the winter. This, along with the critically endangered species status, may prevent the bee from extinction, and even increase future populations.

WHEN THINGS WON'T CHANGE

Every year, the Department of Labor's Occupational Safety and Health Administration (OSHA) releases workplace injury statistics and lists the most frequent safety and health violations. OSHA's most recent report showed that 4,500 workers are killed on the job every year, and 3 million are left injured – many badly enough to end up in the hospital. As a workers' compensation lawyer, the OSHA report isn't news to me. I know how often people get hurt while working. What's troubling is how the violation report doesn't seem to change year after year.

In 2016, the top 10 most cited safety and health violations were:

- Fall protection
- Hazard communication
- Scaffolds
- Respiratory protection
- Lockout/tagout
- Powered industrial trucks
- Ladders
- Machine guarding
- Electrical wiring
- Electrical, general requirements

I have a lot of clients come into my office who are suffering because their employer committed one of these common violations, and falls, lockout/tagout, and machine guarding failures are our most frequent cases. What's worse, this list is almost identical to the list from 2015, and the only change is that machine guarding has moved above electrical wiring. In fact, if you look back 10 years ago at the list from 2006, you'll find the exact same 10 safety and health violations.

We know these are common problems, and if employers would just fix the top 10 violations, it would really cut down on the number of injuries and deaths. By law, employers are required to provide a safe and healthful workplace for their employees, but too many employers are more interested in cutting corners and doing things the cheap way instead of the right way. When employers refuse to correct easy problems, it's employees who always end up paying the most for their mistakes.

At the office, we're always going to be doing our part on this end, but I'd be happy if I didn't have to be standing over a hospital bed, staring down at people whose lives

CAN I CLAIM WORKERS' COMP IF I TELECOMMUTE?

Telecommuting is more popular than ever. Statistics from Global Workplace Analytics show 7 million Americans spend at least half their week telecommuting. With this rise of a new working habit, the legal system has had to decide if telecommuters are entitled to the same workers' compensation benefits as traditional employees. The short answer is yes. However, it can get complicated.

In a workers' comp case, an injured employee doesn't need to prove the accident was the fault of the employer. They just need to show the accident was workrelated. This is much harder to do when an employee is at home rather than at the office or job site. If an employee falls while walking to the office bathroom, they're entitled to benefits. If that same employee were to fall while walking to the bathroom

in their home, insurance companies and defense lawyers will likely argue the accident wasn't work-related at all.

In this case, a big question is whether or not the accident happened during the injured person's working hours. Many telecommuters clock into a computer system to log their time during the day. If an injury occurred when the employee was clocked in, they have a stronger case However, if a 9-to-5 employee decided to work at 7 p.m. and experienced an accident, it may not be considered as having occurred during the course of employment. Additionally, many telecommuters might be considered independent contractors rather than full-time employees. In North Carolina and Virginia, only employees are entitled to workers' comp benefits.
